

 - Is independently developed by the recipient party without access to the information; or
 - Is required by law or regulations to be disclosed.

10.2 All Confidential Information shall remain the exclusive property of Disclosing Party, and Recipient shall have no right to use Confidential Information except as provided herein. No patent, copyright, trademark or other proprietary right or license is conveyed by this MOU with respect to Confidential Information. 5. Party-2 shall make the payment within the specified timelines as per **Annexure-2**.





6. Party-1 shall be conducting a practical course on Goods and Services Tax for the 3rd Year B.Com and 2nd Year M.com students as per Annexure-1.


Report on CRT Classes for B.Com, B.Sc & BA Soft Skills and Aptitude Training
